ASEAN - Hong Kong, China Free Trade Agreement Enters into Force

The tariff reduction commitments of five ASEAN member states, namely **Laos**, **Myanmar**, **Singapore**, **Thailand** and **Vietnam**, under the "ASEAN – Hong Kong, China Free Trade Agreement (FTA)", has entered into force today (June 11).

Form AHK CO

Provided that the FTA's origin rules are met, Hong Kong manufacturers and trades can apply for the Form AHK Certificate of Origin. Under the agreements, Singapore binds all its customs duties at zero, whereas Laos, Myanmar, Thailand and Vietnam will progressively reduce or eliminate their customs duties on goods originating from Hong Kong. The tariff reduction commitments cover various kinds of Hong Kong commodities including jewellery, articles of apparel and clothing accessories, watches and clocks, and toys.

Movement Confirmation

Provided that the relevant requirements in the FTA are met, Hong Kong traders can apply for the "Movement Confirmation (MC)" to re-export goods originating from one of these five ASEAN countries to another. Goods under MC must not undergo any further processing in Hong Kong, except for repacking or logistics activities (such as unloading, reloading, storing or any other operations necessary to preserve them in good condition or to transport them to the final destination).

《東盟 - 中國香港自由貿易協定》正式生效

在《東盟-中國香港自由貿易協定》下,**老撾、緬甸、新加坡、泰國**和 **越南**五個東盟成員國的關稅削減承諾在今日(6月11日)生效。

香港原產地來源證(Form AHK)

若香港產品符合《自貿協定》的原產地規則,廠商或貿易商可以申請《香港原產地來源證》。新加坡承諾對所有香港原產貨物實施零關稅,而老撾、緬甸、泰國和越南對香港原產貨物徵收的關稅則會逐步減免。關稅減免承諾涵蓋香港不同類型的貨品,包括珠寶、服裝及衣服配件、鐘錶和時鐘、玩具等。

流動證明書

若符合《自貿協定》的相關要求,香港貿易商可以申請《流動證明書》,轉口以上五個東盟成員國的原產貨物至另一個成員國。《流動證明書》的貨品不能在香港作進一步加工,但重新包裝或物流活動(例如:卸下、重新裝載、貯存或為使貨物保存在良好狀態或為運送貨物至最終進口一方所需的其他操作)則除外。
